## JURYING PROCESS

The current Board of the Buffalo Society of Artists review and vote on each candidate. Applicants need to receive a majority of votes to be accepted as an Exhibiting Member. The Board bases their decisions on applicant's professionalism and skill, including originality, creativity, visual aesthetics and presentation. Work submitted should be consistent in quality and style, presenting a cohesive body of work. Notification of acceptance or rejection will be sent by mail the following week.

## APPLYING FOR EXHIBITING MEMBERSHIP

Complete and mail attached application, your resume, brief artist statement and \$15 jurying fee, postmarked no later than **October 7, 2017**.

On review date bring:

1. Three original works of art completed in the last 3 years. Complete labels included in this prospectus and attach one to the back of each artwork submitted.
2. CD or memory stick of 6-10 additional art works completed within the last 5 years. Include an inventory list of artwork with title, size and year completed.

Video artists need to submit their work on DVD. Individual video clips should not exceed 3 minutes in length.

Applicants must be 18 years old and not currently enrolled in an undergraduate degree program related to the visual arts.
